



## Social Science & Dentistry ● Instructions to Authors

All submissions should be uploaded at [www.ssdopen.com](http://www.ssdopen.com).

It is a condition of acceptance of the paper that it is the original work of the author(s) and that it has not been published, nor being considered for publication, elsewhere. It is important that the author(s) declare any potential conflict of interest. Manuscripts will be peer reviewed by two experts in the subject area.

Manuscripts should preferably be provided as Word files with text double-spaced in 12 point and the pages should be numbered consecutively. Main headings should be in upper case and emboldened, subsidiary headings should be in lower case and emboldened. The first page of the paper should give only the title of the paper, the author(s) name(s), qualifications and institution(s). A postal address for correspondence should also be given. The format of the paper should be according to the following convention:

**Abstracts** for scientific papers should be structured. There should be no references. The format of the abstract should be structured as: **Aim and objectives; Design** of the study to include subjects - number of subjects and selection; setting, procedures including the nature of any interventions, main outcome measures, Results and Conclusions. The abstract should be accompanied by no more than five key words and a short running title.

**Manuscripts:** Should follow the conventional layout of: Abstract, Introduction, Material and Method, Results, Discussion, Conclusions, Acknowledgements, References, Tables and Figures. Where necessary, authors should have received ethical approval for their work and this should be recorded.

**Tables:** Should be numbered in Arabic numerals, should be presented at the end of the paper, each with a legend explaining the content of the table without reference to the text. No vertical lines should be included. Where appropriate, consideration should be given to alternative ways of displaying data other than in tables, for example, as histograms.

**Illustrations:** These should be referred to in the text as 'Figure' and given Arabic numbers. Illustrations should not be included in the text of the paper. Please note: the text and tables should be sent in Word, figures/images should be in TIFF, JPEG or EPS format in either greyscale or colour. Please ensure that photographs are not embedded in Word or PowerPoint but are individual files at a high resolution of 300 pixels per inch. Where photographs of people are submitted the necessary consent must have been obtained for their publication.

**Acknowledgements:** These appear at the end of the text, before the reference section. Reference to commercial sponsors should be included in the acknowledgements. Any conflict of interest must be expressly stated.

**References:** Must comply with the Harvard system. Authors are responsible for the accuracy of the references both within the text and in the list. These should appear in the text as the name of the author (s) and the year of publication. Where there are only two authors both should be given thus: (Russell and O'Reilly, 2008). Where there are more than two authors, they should be referred to in the text as: (Williams *et al.*, 2007). Multiple references need to be listed in chronological order. Where an author(s) has published more than one reference in any one year, these should be suffixed as 2006a or 2006b. Personal communication should be avoided but where essential will appear in the text only.

In the reference list the following convention should be followed: For scientific papers: Author(s): family name followed first name(s) initials. A comma is placed after each set of initials, except the last, which is to be followed by a full stop. The full title should follow, in lower case. This is followed by the year of publication; volume number: (emboldened) and first and last pages in full. For books, the title should be followed by the edition, if second or subsequent, the place of publication, the name of the publisher and the year. For a chapter in a book, the style should be as above together with the page numbers after the edition.

**Proofs and offprints/reprints** page proofs will be sent electronically as a PDF file to the corresponding author for checking of accuracy only, essentially typesetting errors. No substantial changes can be made to the paper at this stage. A rapid turn-around is often required to keep to publisher's deadlines. Copyright will be signed over to the publisher.

**Author costs and licences:** On acceptance, after peer review, and before publication the author will be required to pay an Author Processing Charge. Open Access articles will all be published under Creative Commons licences.
